VENUE OF THE EVENT

The ITF Taekwon-Do World Cup will take place at the stadium at Polideportivo Islas Malvinas, in Mar del Plata, Buenos Aires, Argentina. It is located at Av. Juan B. Justo 3525. It has multiple entrances for both the audience and the competitors and coaches, ensuring a smooth and accessible experience for everyone.

HOW TO GET TO MAR DEL PLATA

Mar del Plata is approximately 5 hours 30 minutes away from Autonomous City of Buenos Aires, by train or by bus. For passenger and cargo transportation, there are different options:

- BUS TERMINAL, with more than 40 companies operating, offering over a hundred frequencies during peak season.
- TRAIN STATION: several frequencies with additional services based on demand.
- INTERNATIONAL AIRPORT: equipped for commercial and general aviation.

ONLINE REGISTRATION

Registration for competitors, coaches, VIPs, companions, and others will be in Sportdata coordinated by the International Taekwon-do Federation through ITF-Online (data.itftkd.sport).

The registration must be done by each club or organisation and will be open until September 24th, 2024.

Club registration cannot be done directly with Sportdata. Clubs can only access the Sportdata World Cup registration via ITF-Online. Each club should request ITF-Online (data.itftkd.sport) access from their NA.

After the deadline, no registrations or changes will be allowed.

All non-competitors (e.g. supporters, coaches, VIPs) must be registered for the World Cup event to ensure a fully engaged and well-coordinated participation experience for all.

The competition is limited to 3000 competitors.

As soon as the first 2500 competitors are properly registered in the online system for the event 9th ITF Taekwon-Do World Cup 2024, all additional registrations will be allocated on a waiting list for further revision and approval.

The entries on the waiting list are confirmed according to the time stamp of the registration in the waiting list.



VERIFICATION AND WEIGH-IN

At least one week before the event starts a verification and weigh-in schedule will be published.

All Pre-Junior and Junior competitors must attend the verification and weigh-in on October 27th, 2024 at Teatro Municipal Colón de Mar del Plata located at Hipólito Yrigoyen 1665, at a time to be determined.

All Adult, Senior and Veteran competitors must attend the verification and weigh-in on October 29th, 2024 at the competition hall.

They should bring their competition ID-card (provided during prior accreditation), a valid identification document (passport, or national identity document) and the Declaration of Consent and Data Protection Form.

All competitors must be present at the weigh-in, regardless of the discipline in which they compete.

Competitors must attend the weigh-in wearing ITF-approved dobok pants and a shirt.

Competitors who do not make weight on the first attempt will have one (1) hour to come back for a second and final attempt.

If they do not make weight on the second attempt, they will be eliminated from the sparring competition category without the possibility of moving to another category.

CLOTHING AND PROTECTION GEAR

All competitors must use official and approved protective gear and clothing, as indicated in the ITF regulations and the brands and models endorsed by the Federation. You can consult it in the regulations and the ITF website, https://itftkd.sport.

All sparring competitors must have full protection, headgear,

hand and feet safety equipment all in red and blue colour, according to the draw.

PARTICIPATION FEES

The participation fees are expressed in US Dollars.

All competitors must pay the participation fee to register, whether they are individual competitors, part of a national team, or participating only in team events.

ACCOMMODATION

Accommodation reservations must be made by the responsible party of each country. Please note that the Organizing Committee will not handle any reservations.

The accommodation options will include establishments of various categories (3 options), all of them providing half-board service, including buffet breakfast and dinner. Non-alcoholic beverages are also included.

Alternative dishes for individuals with allergies or special diets will be available if indicated in your request.

The accommodation options will be published shortly. To make a reservation, send an e-mail to:

accommodation@tkditfworldcup2024.com and within 48 hours you will receive a link to a document.

The organizers will verify your reservation and will send you the details for your review and the cost to be paid. Please note that the reservation will not be confirmed until the requested amount has been registered in the account.

It is mandatory to send proof of deposit/transfer indicating name, origin, and amount of the deposit in order to identify it to this e-mail address:

The deadline to pay 50% of the lodging reservation is June 14th, 2024, and the deadline to cancel the remaining 50% of the reservation is August 23rd, 2024.

Those who choose not to book their accommodation in the officially designated hotels will be required to pay an additional fee of USD \$170 per person to receive the corresponding credential.

UMPIRES

The Organizing Committee will offer hotel accommodation for 9 days/8 nights, including full board, from October 26th, 2024, to November 3rd, 2024, for a maximum of 100 selected Umpires, who will be accommodated in double rooms.

All registered Umpires must attend the Umpire meeting on October 27th, 2024 at Hotel Nuevo Ostende (Hipólito Yrigoyen 1737).

Umpires must dress as specified in the ITF rules.

The NA must submit the Umpire Application Form via email to the Umpire Committee at **tuic@itftkd.sport**. The Umpire Committee will select the Umpires and inform them.

Then, the list of selected Umpires and those nominated for accommodation in double rooms will be submitted to the Organizing Committee by the ITF Umpire Committee. Only the NA (or AA in case the NA is not available) can submit the Umpire application list; individual Umpires cannot submit applications.

COACH

Coaches are invited to the online coaches' meetings on Saturday, October 12th at 8:00 pm UTC and at the Teatro Municipal Colon de Mar del Plata, located at Hipólito Yrigoyen 1665, on Sunday, October 27th at 9:00 am local time.

It is the responsibility of coaches to ensure that competitors are seated in the stands. Competitors found in the competition area when they are not called for their competition categories will have their identification documents confiscated by the ITF TUI Committee.



PRESS AND PHOTOGRAPHY

The organization has its own press staff. Those wishing to request a Press Pass should register on Sportdata. There is a registration fee of 200 USD per Press Pass, and a maximum of 2 Press Passes per country is allowed.

If there are more than 2 applications per country, the first 2 applications by time stamp will receive a Press Pass.

ANTI-DOPING COMMISSION

The ITF confirms the presence of the Anti-Doping Commission.

VISA INFORMATION

If you need a visa, you should contact the Embassy or Consulate of Argentina in your country. Please contact the organizing Committee for any inquiries. To easily check which countries require a visa for Argentina and which do not, visit the website of the Ministry of Foreign Affairs of Argentina: argentina.gob.ar.

The Organizing Committee will send an invitation letter to participating teams that require a visa for Argentina, but only upon request from the participating teams. They must submit an application, along with copies of the passports of all applicants, a completed Visa application form, and confirmation of payment of 50% of the hotel accommodation amount. The aforementioned VISA application should be sent via email to the Organizing Committee: info@tkditfworldcup2024.com.

CURRENCY

The currency used in Argentina is the Peso. If you haven't exchanged your currency before arriving in Mar del Plata, you can inquire about the locations of Forex branches and nearby bank branches from the organizers. There are also numerous ATMs in the city center of Mar del Plata and near the hotels.

INSURANCE




